Pursuant to the provisions of Article 295 paragraph 1. of the Capital Markets Act and Article 8 paragraph 1. of the Rules of the Zagreb Stock Exchange Inc. (hereinafter: Exchange), on 24 September 2012, with the the approval of the Supervisory Board dated 21 September 2012 the Exchange Management Board passed the following

AMENDMENTS TO THE EXCHANGE SERVICE PRICE LIST

Article 1

In Article 19 of the Price List a section of the table referring to Structured products shall be amended to read as follows:

Prime Market Official Market Regular Market	Structured products ²		/	/
	1-15	HRK 6,000.00		
	16-30	HRK 4,200.00		
	31 or more	HRK 3,000.00		

At the page bottom under Article 19 of the Price List, a footnote shall be inserted to read as follows:

"²The amount of fee payable for listing structured products in the regulated market depends on the number of structured products listed in the same calendar year. The fee is payable per structured product."

Article 2

In Article 23 of the Price List a new paragraph shall be inserted after paragraph 2 to read as follows:

"If between 16 and 30 structured products are admitted to trading on the MTF in the same calendar year, the fee payable for admission to trading is HRK 4,200.00 per structured product, and HRK 3,000.00 per structured product if more than 30 structured products are admitted to trading."

The former paragraphs 3, 4 and 5 shall be renumbered as paragraphs 4, 5, and 6.

Article 3

These amendments to the Price List shall enter into force on the 10th (tenth) day from their approval by the Croatian Financial Services Supervisory Agency.

The amendments to the Price List shall be posted on the Exchange website www.zse.hr and distributed to all Member firms.
