

Pursuant to the provisions of Article 295 paragraph 1. of the Capital Markets Act and Article 8 paragraph 1. of the Articles of Association of the Zagreb Stock Exchange Inc. (hereinafter: Exchange), on 21 May 2013, with the the approval of the Supervisory Board dated 27 May 2013 the Exchange Management Board passed the following

AMENDMENTS TO THE EXCHANGE SERVICE PRICE LIST

Article 1

In Article 5 item 2 the words: "for each subsequent financial instrument" shall be substituted by the words: "for each subsequent share".

Article 2

In Article 7 item 1 shall be deleted.

Article 3

In Article 13 paragraph 3 after the word: "Specialists", the following words shall be added: "in respect of shares".

Paragraph 4 shall be amended to read as follows:

"Specialists in respect of structured products are entitled to a discount equal to 40% of the fee set forth in Article 11 paragraph 1 item 1 payable on the total daily turnover effected in the capacity of Specialists."

Article 4.

In Article 19 of the Price List a section of the table referring to Structured products shall be amended to read as follows:

Article 6

Article 23 paragraph 2 shall be amended to read as follows:

Paragraphs 3 and 4 shall be deleted.

The former paragraphs 5 and 6 shall be renumbered as paragraphs 3 and 4.

At the page bottom under Article 23 of the Price List, footnote No. 3 with the following text shall be inserted:

"³ The amount of fee payable for admitting structured products to trading on the MTF depends on the number of structured products admitted in the same calendar year. The fee is payable per structured product."

Article 7.

These amendments to the Price List shall enter into force on the 10th (tenth) day from their approval by the Croatian Financial Services Supervisory Agency.

The amendments to the Price List shall be posted on the Exchange website www.zse.hr and distributed to all Member firms.
