# Transitional and final provisions Article 6

(1) This Amendments to the Price List shall enter into force on April 1, 2023.

(2) As an exception to paragraph 1 of this Article, for users who have concluded a contract for the service of publishing trading reports for the account of investment companies (APA) and for the service of using and distributing trade data, at the time of entry into force of this Amendments to the Price List, fees mentioned in the Article 1. and 2. of this Amendmets to the Price List apply from July 1, 2023.
