1 Preface

1.1 Foreword by the Management Board

The first half of the year was marked by optimism, predominantly thanks to the long-awaited accession of the Republic of Croatia to the European Union, and most efforts in that period were aimed at harmonising the country's regulatory framework with that of the EU. In that respect, a major reconstruction of the text of the Rules and other regulatory Exchange documents was undertaken to bring them in line with the Capital Market Act while also introducing new services in order to provide for more transparent, efficient and effective functioning of the local capital market.

Six new indices introduced in February enabled easier monitoring of market trends and a more comprehensive market overview; they are only a first step in further development of data groups to give investors a better insight into market developments, thereby facilitating investment decision making, which is also supported by a changed format and expanded contents of trading reports.

In the course of 2013, much attention was paid to raising the level of transparency of listed companies and to education: it was the year in which the local capital market got its first certified investor relations managers. That programme, unique not only in Croatia but also to the neighbouring region, is in its entirety an innovation of the Zagreb Stock Exchange aimed at promoting the corporate governance culture and professional investor relations.

The ZSE Academy addressed the educational needs of the financial community for the fourth consecutive year, with more than 600 participants attending numerous training courses and seminars. A series of meetings, roundtables, conferences and other events were organised, providing an opportunity to the market participants to establish stronger ties, exchange knowledge and experience, and open a dialogue on the steps which should be taken to enable further development.

The Exchange continues to focus on improving the corporate governance level and enabling further education of issuers. Its new electronic issuer surveillance system, implemented in the second half of 2013, facilitated monitoring of whether issuers perform their obligations in a timely manner while also contributing to raising the transparency level, as an essential factor of optimal functioning of the capital market in general and an element closely tracked and evaluated by investors, foreign investors in particular, especially since Croatia has become a part of a single European economic area.

Other important moments worth mentioning include numerous new issues of certificates – as another proof of the fact, confirmed in 2013, that the market really needs novelties and accepts them readily – as well as other share issues requiring the engagement of specialists to support their market liquidity, and longer trading hours.

In general, a challenging economic environment protracting into its fifth year now had a major impact on the capital market, especially on the issuers; more than 40 of them, accounting for 20% of the total listed companies on the Zagreb Stock Exchange alone, found themselves at some stage or another of pre-bankruptcy proceedings in 2013.

However, while awaiting the first signs of economic recovery which are often mirrored precisely on the exchange, we continue to work on enhancing the transparency of listed companies, on new products and services while also striving to further increase market efficiency.

At the very end of the year, the Zagreb Stock Exchange Award ceremony cast a ray of optimism on the general situation. Presented in seven categories, it keeps alive the tradition of providing recognition and support to the very best, since excellence certainly deserves acknowledgement, in the hope that the future may bring many more such upbeat occasions.

1.2 The Zagreb Stock Exchange in 2013

Trading on the Zagreb Stock Exchange showed no considerable deviations in 2013 compared to the previous year's levels: order book share turnover suffered a -6.8% correction; however, total turnover was no more than -1.2% weaker, thanks largely to solid share block trades, as well as to trading in commercial papers and structured products which account for 4.5% of the total turnover.

With the exception of CROBEXkonstrukt (-14.2%), the indices recorded 2013 increases in the range between +1.25 (CROBEXnutris) and as much as +40.7% (CROBEXturist), while CROBEX© and CROBEX10® indices closed +3% and +2.4% higher, respectively, than a year earlier.

A list of ten shares with the largest market capitalisation remained virtually unchanged, with the five top ranking issues accounting for almost 60% of the total market capitalisation.

The most liquid share ranking, which continues to be topped by Hrvatski Telekom d.d. share, was similar and more than a half of liquidity was concentrated in the top ten shares by turnover.

The fact that several share issuers engaged specialists in 2013, bringing the number of shares with specialists supporting their market liquidity to a total of seven – and four of these requiring specialist activities of two ZSE member firms – represents another breakthrough for the market.




Chart 1: Orderbook turnover (mil HRK)




Chart 4: Zagreb Stock Exchange equity index CROBEX®




Chart 5: Zagreb Stock Exchange equity index CROBEX10®




Chart 6: Zagreb Stock Exchange equity index CROBEXplus®





Chart 7: Sectors with the highest Market Capitalization




Chart 9: Market Capitalization structure




Chart 10: Free Float Market Capitalization structure




Chart 11: Structure of equity turnover
